Rewire is organized and operated as to attract new and additional public support and funding on a continuous basis. The organization maintains a continuous and bona fide fundraising program for solicitation of funds from the general public. Part of Rewire's fundraising program includes email and online solicitation, which garnered Rewire numerous donations from 384 different individuals in 2016. The ongoing fundraising efforts are expected to raise the public support percentage in future years. Its current sources of support include a variety of private foundations, public charities, businesses and individuals.
